R E S O L U T I O N

In view of the rise in the price of Petrol and Diesel Government is pleased to direct that existing rates of Road Mileage should be revised in appropriate cases. The rates for various categories of journeys/vehicles including the revised ones should be as under :

1. Government Employees using owned/hired/borrowed conveyance:

(A) Government Employees of the first or Second Grade :

<u>Conveyance by which journey performed.</u>	<u>Rates of Road Mileage</u>
(1) Motor Car owned/hired/borrowed (Petrol driven)	2.65 paise per K.M.
(2) Two Wheelers (Motor Cycle/Scooter)	70 paise per K.M.
(3) Any other means of conveyance.	70 paise per K.M.

(B) A Government Servant of third or fourth grade :

(1) Owned/hired/borrowed two wheelers (Motor cycle/Scooter)	70 paise per K.M.
(2) Any other means of conveyance	70 paise per K.M.

In case of hired conveyance, the actual cost of hiring the conveyance in whole or in part will be payable subject to the limit of the Road Mileage rates prescribed above.

(C) Road Mileage for journey performed in petrol driven vehicles supplied by Government on rental basis to Government officers. These rates should be increased from 1.75 paise to 2.10 paise per K.M.

(D) The rates of Road Mileage in respect of Diesel driven vehicles will be as under:

Conveyance by which journey is performed.	Rates of Road Mileage.
(1) Car, jeep etc. supplied by Government on rental basis	90 paise per K.M.
(2) Owned/hired/borrowed Car, Jeep etc.	1.45 paise per K.M.

2. The conditions mentioned in Government Resolution, Finance Department NO: PCR/3275/G/M, dated the 30th April, 1975 will continue to remain in force.

3. These orders will take effect from 15th October, 1980. The supplementary claims appropriate to the difference, of the old and the revised rates of Road Mileage on the basis of these orders should be allowed to be preferred.
